

MOE'S AND POE GARDEN GRANT CONTEST

OFFICIAL RULES

NO PURCHASE NECESSARY, VOID WHERE PROHIBITED OR RESTRICTED BY LAW. A purchase does not improve one's chance of winning.

ELIGIBILITY: Open to all United States residents who are 18 years of age or older. Nominated school must be Triangle area elementary schools, grades K-5. Independent contractors associated with and employees of The Poe Center or Triangle Area Moe's Southwest Grill locations, and the immediate family members or persons residing in the same household of such employees are not eligible to enter or win.

HOW TO ENTER: To enter the Moe's and Poe Garden Grant Contest "Garden Grant" giveaway, submit your entries at any Triangle Moe's location, at the Poe Center or on the Poe Center's website (www.poehealth.org), now until April 13, 2014. Ten finalists will be chosen, five schools with existing gardens and five without, and beginning April 21, 2014, Triangle Moe's Facebook fans can cast votes for their favorite school finalist on the Triangle Moe's Facebook page (<https://www.facebook.com/MoesTriangle>) by clicking on the app titled "Garden Grant Contest" located directly under the Moe's Triangle cover photo. Only votes submitted between 12:00am EST on April 21st and 12:00am EST on April 30th will be eligible to win. The two schools that receive the most votes will win a \$1,000 Garden Grant from the Poe Center. The winning schools will be announced on Moe's Triangle Facebook page and the Poe Center's Facebook page (<https://www.facebook.com/poecenter>) on May 2, 2014.

PRIZE: The two winning schools will each receive a \$1,000 Garden Grant from the Poe Center to be used to plant a garden or expand an existing garden. The grant will be awarded to the school, not the entrant.

GENERAL: Prize is non-transferable. All taxes or expenses and any costs incurred in claiming or using any of the prizes, are the sole responsibility of the prize winner. All federal, state and local taxes are the sole responsibility of the winner. No prize substitutions, except at Sponsor's sole discretion, and then only for a prize of equal or greater value.
